Annotation:

This Proficient exemplar shows an understanding of the structure of an interview narrative and provides an adequate description of the interviewee through description, details, and embedded quotations that present the subject's voice. The essay provides vivid descriptions of the interviewee's emotional reactions: "His eyes are filled with tears by now and he had to stop talking to take a deep breath." This comment and others create a good sense of the subject of the interview. Purposeful quoting such as, "I don't regret going to the military," also illustrates character and presents the subject's distinct point of view. The exemplar maintains a mostly consistent focus on the subject's point of view, though switching among first, second, and third point of view creates some narrative confusion. Despite obvious lapses in sentence structure, the writing demonstrates a general command of sentence structure and conventions and a need for careful proofreading.
